

# **Call For Entry: B-40 NC Artists Under 40**

The Arts Council of Wilmington and NHC Gallery @ ILM

**Entry Deadline: May 1, 2017**

This exhibit is open to all artists under 40 years of age whose county abuts I-40. We recognize the significance of Interstate 40 as a main access point to our region and hope to celebrate the talented visual artists that live in counties that touch I-40.

The Arts Council of Wilmington and NHC will showcase selected artists at The Gallery at Wilmington International Airport during the summer season. This is a great opportunity to reach thousands of people that travel through ILM each summer.

**All entries are due by Monday, May 1, 2017.**

**Artists will be notified of acceptance by Thursday, May 4, 2017.**

## **ELIGIBILITY**

Open to all artists 18 years & older, amateur & professional. All media will be considered, this includes but is not limited to painting, drawing, photography, printing, mixed media, and sculpture (as long as it can hang on a wall, no free-standing sculptures). There are no limitations on subject matter or materials.

## **ENTRY SPECIFICATIONS**

All media in 2D forms will be considered. 3D work must be able to hang on a wall. All work must be suitably framed and/or prepared to hang with all hardware readily attached. There is no minimum size requirement and larger pieces must be able to enter the gallery through an 84" x 70" doorway. Once installed, work may not exceed 7 feet in height.

### **1-3 entries per artist may be submitted FREE of charge**

Each jpeg must be limited to 1024 pixels on the longest side and no larger than 1MB.

Submissions that do not comply with these rules will not be presented to the juror.

## **PUBLICITY**

The Arts Council of Wilmington reserves the right to photograph and reproduce, in color or black & white, all artworks accepted for this exhibition, regardless of copyright, for educational and/or publicity purposes.

## **SALES, LIABILITY, AND INSURANCE**

The Arts Council of Wilmington will retain a 30% commission on all sales directly attributed to the exhibition. All prices (including frame and mat) set by the artist at the time of entry should include the 30% commission. The Arts Council will provide a contract with more information upon acceptance of artwork.

## **DELIVERY & PICK-UP**

Accepted works are to be hand-delivered to The Wilmington International Airport on May 19, 2017 at a specified time decided upon acceptance. Accepted works must remain for the duration of the exhibition (**May 19, 2017 – August 18, 2017**). Works must be picked up at the close of the exhibition or work becomes property of The Arts Council of Wilmington to dispose of as it sees fit.
